A. **BBQ Project, Discussion, Action** – Discussion started by Ken thanking the Ad Hoc Committee of Oliver, Linda, Jim Woolf and Jan Zobrist for their time and efforts in working with the staff and the contractor on this proposal. Discussion continued with Oliver, Linda and Jan Zobrist commenting on the project and meeting with staff and the contractor. A motion was made by Linda and seconded by Karen to approve the proposal from Qualcraft in the amount of \$124,412 with contingencies of \$5,588, totaling \$130,000 to start this project as soon as possible and to be completed no later than May 31, 2022. HVAC System for Beach Club and Health Club, Discussion, Action – A **motion** was made by Linda and seconded by Alma to approve the proposal submitted by Phil's Mechanical Heating & Air Conditioning to remove and replace the HVAC systems at both the Beach Club and the Health Club in the amount of \$45,070, with a contingency amount for the project not to exceed a total of \$50,000. The amount of \$45,070 includes a crane service. Also, this project needs to be completed no later than May 31, 2022. **The motion passed 10-0.**
